- Lindsey Munoz, OGSD inquired about how (1) districts are providing assistance for students who need temporary 1:1 care due to injuries (broken bones). A wide array of personnel have been used Special ed aides, Para educators, Admin, subs. Resource available Ro Health (206) 486-1638 for non-licensed UAP. (2) She also brought up a question about who are the 504 coordinators at the school sites? Again a wide range of responses but not usually the school nurse. (3) Who manages the audiology equipment (FM systems) Not usually the school nurse speech and language specialist or hearing specialist for the County. (4) Is a physician authorization necessary for cough drops? Yes They are considered OTC and would require a physician authorization
